# Report on Series of LLM Dissertation Consultations by Prof. Dr. K. I. Vibhute at Symbiosis Law School, Pune

Symbiosis Law School, Pune, organized a series of LLM dissertation consultations from May 2024 to July 2024 for students specializing in various fields of law, including Business and Corporate Law, Innovation Science Technology Law, Constitutional and Administrative Law, Human Rights Law, Criminal and Security Law, Family Law, EU & International Law, and TMT (Technology, Media, and Telecommunications) Law & Law Policy. The consultations, conducted by the esteemed Prof. Dr. K. I. Vibhute, Distinguished Professor at SLS Pune, were aimed at guiding students through the critical aspects of dissertation research, writing, and presentation in their respective areas of specialization. The event saw the active participation of over 70 students.

### **Overview of the Consultation Series**

The consultation series was designed to provide LLM students with expert guidance on crafting well-researched, academically rigorous dissertations. Prof. Dr. K. I. Vibhute, a renowned academic with deep expertise in a wide range of legal disciplines, took the lead in offering personalized guidance to students across diverse fields of law. The goal of the consultations was to ensure that each student developed a clear, focused research question, applied suitable methodologies, and adhered to the highest academic standards throughout their dissertation work.

The consultations were structured as one-on-one sessions and group discussions, providing students with the opportunity to seek advice on the various stages of their dissertation journey. These included the selection of a research topic, literature review, formulation of research questions, legal analysis, data collection, and structuring of the dissertation.

#### **Session Themes and Focus Areas**

The consultation series covered a broad spectrum of legal fields, allowing students to engage with Prof. Dr. Vibhute's expertise in different contexts. Below is an overview of the key areas addressed during the consultation sessions:

## 1. Business and Corporate Law

In the Business and Corporate Law segment, Prof. Dr. Vibhute provided valuable insights into corporate governance, mergers and acquisitions, business ethics, and regulatory frameworks. Students were advised to focus on current issues in corporate law, such as the role of corporate social responsibility (CSR) in business practices and the impact of international trade laws on corporate entities. The consultations stressed the importance of linking legal theory with business practices and analyzing case studies to highlight the practical implications of corporate law.

Prof. Dr. Vibhute encouraged students to explore evolving areas like blockchain technology in corporate governance and the influence of artificial intelligence (AI) on corporate decision-making. This provided students with a modern and dynamic perspective, ensuring that their research contributed meaningfully to the academic and professional discourse in corporate law.

## 2. Innovation Science and Technology Law

The Innovation Science and Technology Law sessions addressed the intersection of law, science, and emerging technologies. Prof. Dr. Vibhute guided students in exploring legal issues surrounding patents, intellectual property (IP) rights, cybersecurity, and the ethical implications of AI and biotechnology. Emphasis was placed on the rapid pace of technological advancement and the need for adaptive legal frameworks to address the challenges posed by these innovations.

Students were encouraged to examine the role of IP laws in fostering innovation, the legal regulation of data privacy, and the impact of emerging technologies like quantum computing on existing legal structures. Prof. Dr. Vibhute advised students to stay abreast of contemporary technological developments and understand how the law can evolve to balance innovation with legal protection.

#### 3. Constitutional and Administrative Law

In the Constitutional and Administrative Law sessions, Prof. Dr. Vibhute focused on fundamental constitutional principles, such as the separation of powers, fundamental rights, judicial review, and the evolving role of administrative agencies in governance. Students were encouraged to explore the interaction between constitutional law and administrative law, focusing on landmark cases that have shaped the interpretation of constitutional provisions in India and other jurisdictions.

A key area of discussion was the balance between individual rights and state power, particularly in areas like freedom of speech, privacy, and national security. Students were also encouraged to consider how constitutional frameworks can adapt to contemporary challenges such as federalism, decentralization, and the protection of minority rights.

## 4. Human Rights Law

The Human Rights Law consultations delved into international human rights conventions, state responsibility, and the enforcement of human rights in both national and international contexts. Prof. Dr. Vibhute emphasized the importance of examining human rights treaties, such as the Universal Declaration of Human Rights (UDHR), and understanding their implementation mechanisms.

Students were encouraged to focus on contemporary human rights issues, such as climate change, refugees, and digital rights. Prof. Dr. Vibhute guided students to consider the legal mechanisms available for addressing human rights violations, including international human rights courts, and explore case studies to illustrate the enforcement and protection of human rights.

## 5. Criminal and Security Law

In the Criminal and Security Law consultations, Prof. Dr. Vibhute provided expert guidance on key issues such as criminal justice reform, counterterrorism laws, international criminal law, and the balance between national security and individual liberties. He encouraged students to explore topics like the legal challenges of cybercrime, the use of surveillance technologies in criminal investigations, and the role of international tribunals in prosecuting war crimes.

Students were advised to research the intersection of criminal law with emerging global issues, such as the use of drones in military operations, the legal ramifications of cybersecurity breaches, and the evolving landscape of international human rights law in conflict zones.

### 6. Family Law

The Family Law consultations focused on the legal aspects of marriage, divorce, child custody, inheritance, and domestic violence. Prof. Dr. Vibhute provided insights into the evolving interpretation of family law in response to changing societal norms, with a particular focus on gender equality and the protection of women's rights.

Students were guided to explore the influence of legal reforms on family structures and the impact of globalization on family law, such as transnational marriages, cross-border custody battles, and the legal implications of assisted reproductive technologies.

#### 7. EU & International Law

Students were encouraged to research the challenges facing international law today, such as climate change, human rights abuses, and international conflict. Prof. Dr. Vibhute provided guidance on how to analyze complex international legal issues and the interplay between international treaties and domestic law.

## 8. TMT Law & Law Policy

The TMT Law & Law Policy consultations focused on the legal challenges in the technology, media, and telecommunications sectors. Prof. Dr. Vibhute guided students in examining issues like net neutrality, the regulation of digital platforms, intellectual property rights in the media industry, and the intersection of technology and privacy laws.

Students were advised to explore the implications of emerging technologies such as AI, big data, and 5G on law and policy. Prof. Dr. Vibhute encouraged them to consider the broader societal impact of technological advancements and how law can adapt to regulate emerging industries while fostering innovation.
